# **Topics of Interest**

#### Negotiations Switzerland – EU

The EU-Finance Ministers agreed to the Directive on savings income in form of interest payments. The text is available at: <u>http://register.consilium.eu.int</u>/pdf/en/03/st07/st07242en03.pdf.

Negotiations on the Dossiers Schengen/Dublin and Combat of Fraud are not yet concluded. It must be expected that the agreement between Switzerland and the EU on the paying agent tax will not be signed before final conclusion of negotiations in these two fields.

#### Basel II

The Basel Committee on Banking Supervision has published one more consultative paper (www.bis.org/bcbs /cp3ov.pdf). It proposes further modifications, especially with regard to credit risks and requirements on public disclosure. The Foreign Banks have included their comments into the position paper of the Swiss Bankers' Association.

The US Comptroller of the Currency confirmed that the USA are not interested in having implemented the Basel Committee's recommendations by all banks.

#### Trust

On the occasion of a meeting between representatives of the Federal Department of Justice and Police and the Swiss Banks, the latter underlined the importance of Switzerland ratifying the Hague Agreement on Trusts and wished this step to be given high priority.

#### Anti-Money Laundering: Levelling the playing field

### New Legislation – Switzerland

#### "Market Behaviour Rules"

The Swiss Federal Banking Commission hopes to adopt a Circular on market behaviour by the end of the year. It is to address issues such as insider dealings and price manipulations and is related to the Attribution Directives for New Emissions and the revision of Insider Legislation in the Penal Law; the latter being in preparation by an expert group.

The Federal Council has published its Message on and a draft of the new Data Protection Act (French

and German). Only few modifications proposed by the Banks seem to have been taken into account.

#### **Depositor Insurance**

The Swiss Parliament is debating whether the Swiss Bankers' Association's Convention on Depositor Insurance should be declared mandatory. The upper limit would be increased from CHF 1 to 4 bio; half of this amount would have to be covered by banks' liquidities. # New Legislation – International

#### Cross-border Services with Germany

A final regulation governing the Cross-border Services is still being looked for and cannot be expected soon. It cannot be excluded that an intermediate solution will be defined awaiting the entry into force of a final legal framework. The definition and interpretation of the term "Passive Provision of Services" is crucial to the agreement. Those concerned agree on its liberation from a formal authorization although further details remain still to be defined.

#### Sarbanes-Oxley Act

The Sarbanes-Oxley Act extends requirements of information imposed on companies and reinforces the supervisory and penal framework. It concerns companies listed on US stock exchanges, their affiliates and – according to the legislator – their auditors. It thus directly concerns Swiss auditors.
